
Sir,

I am directed to refer to Board of Governors in supersession of Medical Council of India's letter No. MCI-37(1)(Recog.-3)(UG)/2018-Med./109730 dated 07.05.2019 on the subject mentioned above and to convey the approval of the Central Government to the recommendation of BoG-MCI for recognition of the MBBS degree awarded by **Maharashtra University of Health Sciences, Nashik** when granted **on or after December, 2018** for increased number of seats from 100 to 150 in respect of the students being trained at **Smt. 3. This issues with the approval of competent authority.


